- 6. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a scanned copy of the bid security in pdf format amounting which shall be valid for 30 days beyond the validity period of the bid.
- 7. Bids shall be opened in the presence of Bidders' representatives who choose to attend at above mentioned date and time at the office of Jugal Rural Municipality.
